RAISE AWARENESS ABOUT #YOUTHVGOV

Writing **op-eds** and **letters to the editor** about climate issues is a great way to raise the profile of climate issues in your own communities and to bring attention to the youth-led legal actions—represented and supported by Our Children's Trust—around the world. In your own voice, you can explain why you support the rights of youth to a stable, healthy climate, and you can encourage others to take action as well.

Whether it's climate lawsuits or congressional resolutions, we need people like you to demand that the courts protect the constitutional rights of youth to a stable climate. Read on to learn how to boost awareness of climate issues and support #youthvgov climate cases—all from your own home!

OP-ED


Op-eds are a way for readers of a news publication to amplify an issue that is important and not getting enough coverage. The best op-eds are written in response to a very recent or soon-to-happen event, such as a development in an Our Children's Trust case or the start of a new wildfire.

In an op-ed, you make a case for why people should know about the event, how that event connects to larger themes (like climate change), and how you are personally affected.

LETTER TO THE EDITOR

Letters to the editor are reader responses to recently published news articles or segments. In other words, a letter to the editor responds to existing coverage.

In a letter to the editor, you can express disagreement with the way a story was covered, the conclusions it drew, or the themes highlighted, and you can make a case for how you think the story should have been presented instead. The goal is to add nuance to the news coverage by sharing your own story and expertise.



WRITE AN OP-ED WHEN...

- There is a development in one of the legal actions led by Our Children's Trust (e.g., a new lawsuit is filed, an ongoing lawsuit receives a ruling, or one of their cases gets a hearing date)
- Something happens in your community that's connected to climate change (e.g., a wildfire creates air pollution or threatens your town)
- New scientific studies are released that are relevant to how your community should respond to climate change

WRITE A LETTER TO THE EDITOR WHEN...

- A news source you read reports on legal actions led by Our Children's Trust or mobilization efforts led by Earth Guardians
- A news source you read publishes a story about youth climate movements but does not mention Our Children's Trust or Earth Guardians
- You want to boost awareness of Our Children's Trust cases in a smaller publication (like a school newspaper) that may not have an op-ed section

TEMPLATES

Writing in your own voice and from your own experiences will always be the most effective way to write a memorable, inspiring, and compelling op-ed or letter to the editor. However, there are some tried-and-true structures that you can follow to help you brainstorm, organize your thoughts, and create a clear and polished final draft. Use the templates below if you want some help getting started.

OP-ED

Provide Context (5-7 sentences)

- Describe the specific recent event you're responding to.
- Connect that event to the issue you're writing about (e.g., climate change)
- State your main point.

Give Examples (10-15 sentences)

- Explain why this issue matters to the readers of this publication, giving specific, local examples.
- Describe the consequences of inaction or lack of awareness.
- Establish your own stake in the issue.

Call to Action (5-7 sentences)

- Describe what steps are necessary for improvement and how people can help.
- Cast a vision for the future.

LETTER TO THE EDITOR

Provide Context (2-3 sentences)

- Name the article you're responding to and the date it was published.
- Identify a specific quote or point you're commenting on.

Make Your Point (4-5 sentences)

- Explain why you agree or disagree with the article any what you think was stated well or left out.
- Provide evidence and examples that show why your point is important.

Call to Action (2-3 sentences)

- Tell readers why they should care and learn more about the topic at hand.
- If appropriate, express support of the paper for their coverage of the issue while also asking for better, broader, or more detailed future coverage.

VRITING TIPS

- **Act quickly.** News moves fast, so write and submit your op-ed or letter to the editor within a couple days of the event or article you're responding to.
- **Speak clearly and proudly from your identity** (*e.g.*, "As a young person..." or "As a parent of two young adults...").
- **Keep it specific and to-the-point.** Ask yourself: What would I say if I only had 10 seconds? Start writing from there.
